No.4/1-2/2025-KMC: It is hereby informed to all the interested registered Firms, Societies, NGOs, Clubs/Organizations existing within the spatial jurisdiction of Kakching Municipal Town that the auction sales of contract for Toll Tax and Parking Fee Collection for 1 year (from 01/04/2026 to 31/03/2027) for the financial year, 2026-27 of Kakching Municipal Council will be held on 23.03.2026 at 11:30 AM in the premise of Kakching Municipal Office. Separate application forms of the 2 items can be obtained from this office during office hours from 12/03/2026 to 20/03/2026.

**Terms & Conditions of the Sales of Contract :**

1. Cost of contract form is Rs. 1,000/- each.
2. Last date of form submission is 20/03/2026.
3. Minimum bid amount of the tender for Toll-Tax is Rs. 80,000/- per month and Rs.85,000/- per month for Parking Fee Collection.
4. Updated bank account statement of the organization with sufficient Credit balance (at least the minimum bid amount) has to be submitted.
5. A cheque of minimum bid amount written in favour of the Sr.Chief Executive Officer, KMC shall be submitted as earnest/security deposit which will be returned just after the tender process is over except for the winners.
6. Updated/Valid Registration Certificate/Letter along with the list of members of the organization issued by the competent authority shall be submitted.
7. Organizations constituted with any member who has defaulted contract amounts in the last 10 years shall not be entertained in this tender of contract.
8. 6 (six) times of bidding amount should be deposited by the winners on or before 26/03/2026 in the Municipal account as advance payment of the first 6 months. If failed, the contract is liable to cancel automatically and the security deposit will be forfeited and the 2<sup>nd</sup> highest bidder in the tender sale will be treated as the winner.
9. Properly filled-up tender form shall be submitted in a sealed envelope with detailed particulars and the cheque & other documents in an unsealed envelope.
10. There will be no exemption in Tax/Fee for Sundays, General Holidays & Nongma Panba.
